Procedure

This report covers the tenth year for monitoring eagle activities at the four hydroelectric facilities of Boyce Hydro, LLC. The facilities include the Sanford (P-2785), Edenville (P-10808), Secord (P-10809) and Smallwood (P-10810) dams and reservoirs. A recording sheet has been developed and is used to record sightings. The plant operators watch for eagles and at the time of sightings make entries on the sheets.
