Dear Secretary Bose:

As requested by the Commission, Boyce Hydro Power, LLC (Boyce), submits the April 18, 2011, order of the Gladwin County, Michigan, Circuit Court pertaining to payment of real estate taxes regarding certain tax parcels in the County.

Boyce requests privileged treatment for the amounts of Boyce's obligations under the court's order pursuant to the provisions of 18 C.F.R. § 388.112 (2010). The amount of Boyce's tax obligations is commercially sensitive information of a kind that is not generally made available to the Commission's public records, and the disclosure of which may cause business injury to Boyce. Accordingly, this information should be treated as privileged and confidential. The public version of this filing has been appropriately redacted and is attached to this cover letter. The privileged version is included on a separate file and has been clearly labeled as "Contains Privileged Information – Do Not Release.

January 17, 2012






IT IS FURTHER ORDERED that if any of the above payments are not met, the County Treasurer shall be immediately entitled to foreclose upon those parcels for which taxes have not been paid pursuant to the above payment plan. Such a foreclosure hearing shall be set with proper notice under the Michigan Court Rules.

IT IS FURTHER ORDERED that this Court shall retain jurisdiction of this matter for the purposes of enforcing this order.
